The Pricing, Data Analysis, and Coding (PDAC) Contractor provides Healthcare Common Procedural Coding System (HCPCS) assistance to manufacturers to ensure proper coding of Durable Medical Equipment, Prosthetics, Orthotics, and Supplies (DMEPOS). The PDAC has reviewed the above listed product. It is our determination that the Medicare HCPCS code to use when billing the four Durable Medical Equipment Medicare Administrative Contractors (DME MACs) is:

L1902 - ANKLE FOOT ORTHOSIS, ANKLE GAUNTLET, PREFABRICATED, INCLUDES FITTING AND ADJUSTMENT

The code L1906 was not assigned as this product does not have a footplate. In order for an ankle orthosis to provide multiligamentus support to the ankle, it must have a rigid foot plate. This foot plate, which by means of attachment to each side of the ankle, provides functional tracking and offers hind foot and mid foot stability during ambulation. This, in conjunction with wrap around straps and the inherent gauntlet design, offer areas of multiligamentus support as described by the code.

This product also does not meet code L4350 as it is not a stirrup brace. This is a sleeve type device.



Based on the inherent design, this orthosis provides ankle support with longitudinal "air cell" arch support. The orthosis provides rigid support through the ankle and uses wrap around strapping to limit the ankle motion. The orthosis provides ankle gauntlet support in same or similar respects as items coded L1902.

The PDAC provides coding decisions based on the coding guidelines established by the Local Coverage Determination (LCD) and associated policy article developed by the DME MACs. All products submitted to PDAC for a coding verification review are carefully examined by coders and professionals following a formal, standardized process.

This decision applies to the application that we received on July 29, 2011. If information submitted in that application has changed or were to change, it could impact our decision. Therefore, a new application would need to be submitted for HCPCS coding verification review. This coding decision will be available within ten (10) working days on the Durable Medical Equipment Coding System (DMECS), which is located on the PDAC web site, www.dmepdac.com. Please take the time to verify that this coding decision is correctly reflected in DMECS.

It is the responsibility of manufacturers and distributors to notify the PDAC immediately of any changes involving their products, related to their current listing on the Product Classification List (PCL) on DMECS.
